中国航空器材集团有限公司为国有独资公司,由国务院国有资产监督管理委员会代表国务院履行出资人职责。集团公司 制定的董事会议事规则和有关工作细则等规章制度,保证了董事会工作规范性,提高了董事会决策的科学性;集团党委 坚决落实把党委研究讨论作为企业经营决策重大问题前置程序的要求,充分发挥"把方向、管大局、保落实"的领导作用, 党委研究讨论公司改革发展稳定、重大经营管理事项和涉及职工切身利益的重大问题。董事会、党委会、经理层形成了 分工明确、职责清晰、互相制约、运转协调的公司治理结构。

中国航材董事会现有董事席位7名,其中外部董事席位4名。董事会下设战略与投资委员会、提名委员会、薪酬与考核委员会、审计与风险管理委员会四个专门委员会,各专门委员会认真执行议事规则和规章制度,围绕董事会的重要决议事项,充分履行职责,提高了董事会的决议质量和效率。集团公司"三重一大"决策制度和决策会议制度明确规定了党委会、董事会和总经理办公会的决策权限、决策程序、组织实施和监督检查、责任追究等内容,有效规范了各项决策流程、决策行为和决策执行。

China Aviation Supplies Holding Company (CAS) is a state-owned enterprise, with State-owned Assets Supervision and Administration Commission (SASAC) of the State Council serving as a funder on behalf of the State Council. CAS has formulated rules and regulations of the Board of Directors and relevant working instructions to ensure standardization of the work and improve the scientificalness of decisions of the Board of Directors. CAS Party Committee resolutely exercised the Party Committee research and discussion as a prepositive procedure in operation and decision making of major issues of the enterprise, gave full play to its leadership role of "direction setting, overall supervision and guaranteed management". The Party Committee would study and discuss the company's reform and development, major operation and management issues and major aspects involving the immediate interests of employees. The Board of Directors, the Party Committee, and the top management formed a corporate governance structure with clear division of labor, clear responsibilities, mutual restraint, and coordinated operation.

CAS Board of Directors currently has 7 directors, including 4 external directors. Affiliated to the Board of Directors are four special committees, specifically the Strategy and Investment Committee, the Nominations Committee, the Remuneration and Assessment Committee, and the Audit and Risk Management Committee. Each special committee earnestly implements the rules of procedure and regulations, and fully performs duties according to the important resolutions of the Board of Directors, to improve quality and efficiency of resolutions of the Board of Directors. The "three-major and one-big" decision-making system and decision-making meeting system clearly stipulate the decision-making authority, decision-making procedures, organization implementation, supervision and inspection, and accountability of the Party Committee, and the General Manager's office and effectively regulated the decision-making process, decision-making behaviors and decision implementation.



On November 20, 2019, Aviation Engine MRO Training Center held the launching ceremony of LEAP engine training project, and officially kicked off the LEAP series engine related training business. At the same time, CAS took the opportunity to promote business synergy, and built a bridge between CAS and the engine manufacturers in fields of aviation supplies support and service cooperation through the training cooperation platforms, to ultimately booster development of pooling of aviation supplies.





中国航材所属中航材航空救援股份有限公司(以下简称中航材航空救援公司)立足于国家应急管理需求,以搭 建全国航空应急救援资源调度信息平台为主体,梳理收录了包括应急重点场站、航空器及起降场信息、航空公司、 作业资源点、服务保障单位和其他救援单位在内的上万个航空应急相关资源项、近 10 万条属性信息,有效支撑 航空应急救援体系建设。

China Aviation Materials Aviation Rescue Co., Ltd. (hereinafter referred to as "CAS Aviation Rescue Company"), started from the national emergency management needs and built a national aviation emergency rescue resource scheduling information platform, which integrated and collected more than 9,500 aviation emergency-related resources and nearly 100,000 pieces of attribute information covering major emergency stations, aircraft and landing site information, airlines, operational resource sites, service support units and other rescue units, to effectively support the construction of the aviation emergency rescue system.



Its affiliate China General Aviation Service Co., Ltd. completed the construction of the Pooling Platform Company for Aviation Supplies, to realize the normal pooling of key models and important aviation supplies, CGAC, one of the Top10 companies in China, has joined the platform. For the first time, it made use of the tax reduction and exemption policy of the Dongjiang Free Trade Zone, to steadily promote the introduction of Russian-made aircraft, and started the self-operated and agency business of M171 helicopters, and made substantial breakthroughs in the user development of the L410 aircraft.

The year 2019 is a crucial year for the reform of state-owned enterprises. CAS attached great importance to the work deployment of SASAC on the reform and development of state-owned enterprises, insisted on unifying the Party's leadership and corporate governance improvement, and continuously enhanced the vitalities and development motivations of the Group. It adhered to the supply-side reform as the main line, upheld the "enterprise-specific measures", promoted the "Two-hundred Initiative", actively advanced the reform of mixed ownership, established a sound restraint mechanism, and earnestly make reform a driving force for the high-quality development.

Further Improve the Modern Enterprise System and Mechanism

中国航材全面贯彻落实两个"一以贯之",明确党组织在公司法人治理结构中的法定地位,把党的领导融入公司治理各 个环节,全面完成将党建工作要求纳入公司章程工作,形成党委领导、董事会决策、纪委监督、党办/董办和行政办主 抓主办、纪检和法律等职能部门协同的有效工作体系。集团公司董事会不断健全完善工作体系、规范运作程序,充分履 行"定方向、决大事、控风险"职能。

中国航材所属企业37户(不含参股企业),其中,混合所有制企业5户,包括2家科技型企业。通过与非国有方合资 新设和投资入股非国有企业等形式推动混合所有制改革,实现了国有资本与非公经济优势互补,各取所长,共同发展。

CAS fully implemented "ensuring Party's leadership in state-owned enterprises and establishing the modern enterprise system", clarified the legal status of the Party in the corporate governance structure, integrated Party leadership into all aspects of corporate governance, and fully brought the Party building work under the Company's articles of association, to form an effective work system featuring the leadership of the Party committee, decision-making by the board of directors, supervision by the disciplinary committee, heading by the Party Office/ Office of Board of Directors/Administrative Office, and coordinated by functional departments like the disciplinary inspection, and legal departments. The board of directors of the Holding Company continued to improve its work system, standardize operating procedures, and fully perform the functions of "setting directions, determining major issues, and controlling risks".

CAS has 37 affiliates (excluding shareholding companies), of which 5 have the mixed ownership, including 2 technical companies. It promoted reform of the mixed ownership through the establishment of JV with and injecting investment in the private parties, to realize the complementary advantages of state-owned capitals and the private economy.

Steadily Boost Reform of "Three Systems"

Reform of "Three Systems" is not only an important starting point for CAS to deepen its reforms, promote streamlining and elevate guality and efficiency, but also an urgent need to enhance its vitality and competitiveness. For that end, CAS has attached great importance and made meticulous organization, set up a leading group and working group for the reform of the Three Systems, formulated the Program for Deepening the Reform of the Three Systems, taken models of central SOEs in reform as the standard, and successively passed the reform of the tenure system of corporate leaders, the reform of the cadre hierarchy, the optimization of the salary structure and the plans for enterprise annuities; taken the Group headquarters and the "Double-hundred Initiative" enterprises as pilots to carry out trials, and actively and steadily promoted reform measures in terms of cadre cultivation, talent echelon construction, personnel selection and employment, and market-based distribution mechanisms. Through continuously increased efforts, CAS has witnessed primary achievements in the reform.

The Technology & Equipment Company and Bireturn, both the affiliates of CAS and under the "Two-hundred Initiative", formulated and improved comprehensive reform plans, further advanced measures related to employee stock ownership, equity incentives, excess profit distribution and the tenure system for responsible persons, and major tasks like business integration and listing, and continuously perfected market-oriented operating mechanisms. In order to accelerate the overall listing of the aviation supplies pooling platform with Bireturn as the theme and effectively use the capital market to help CAS become better, stronger and larger, the Holding Company set up a leading group for listing to provide overall guidance for listing works, maximize integration of resources and accelerate the reform process.

CAS focused on strengthening and optimizing its main business. While consolidating traditional aircraft centralized purchase and aviation supplies support business, it vigorously developed strategic emerging industries, made prospective layout for the general aviation industry, and conducted industry research work on the integration of general aviation state-owned enterprises. CAS Aviation Supplies Pooling Platform was officially launched and put into operation.

CAS would conduct special rectification and reform of "headquarters institutionalization" as an important task at present and for a period of time in the future. It has set up a special working group targeting at the nine aspects to be immediately addressed as set by SASAC, formulated a special rectification plan, clarified the rectification time limit and responsible department, sought both temporary and permanent solutions, combined the immediately rectification with long-term mechanism, further defined the functional positioning of the headquarters, optimized setting of institutions and posts in a more scientific manner, established a more reasonable organizational system, and strictly controlled the number of departments and personnel: streamlined examination and approval matters, increased authorization and decentralization, strictly limited operation control matters and scope; improved work flow, raised decision-making efficiency, refined the writing and meeting styles, standardized inspection and research, changed work methods, and intensified service awareness; built a high-quality talent team and cultivated an excellent corporate culture, eradicated drawbacks of headquarters institutionalization and achieved phased outcomes in improvement of headquarters' governance efficiency.



Improve the Safety Management System

完善安全管理组织机构 Consummate the Safety Management Organization Structure

CAS and its secondary companies have established safety production committees and exercised a regular safety meeting system.

In order to make the safety management work more institutionalized and standardized, CAS hired a professional safety management consulting company to conduct a three-year comprehensive consulting and standardization work on safety production management of the Holding Company, comprehensively sort out, optimize and detail the institutional system, organizational system, and assessment system, preliminarily establish basic systems such as the safety responsibility system, safety assessment system, and safety emergency management system, thereby to lay a solid foundation for further in-depth development of a comprehensive safety system and improvement of its safety management level.

Define Responsibilities of the Safety Subject

In 2019, the safety production supervision departments at all levels of the Holding Company continued to increase the supervision force on the implementation of safety production work, paid close attention to the implementation of main responsibilities, and timely identified and resolved safety issues to ensure safe production throughout the year.

It strengthened the internal control and management system with "One Strengthening, Three Improvements" as the starting point, continued to carry out strict internal and external safety audits and implement rectifications to ensure flight safety. In the whole year, it realized a total of 7,005 hours of safe flight and 23,634 flights, free of aviation accident or incident, ground production accident, or safety production incident involving personal injuries. Its rate of serious errors was 0.43 per 10K flights, both significantly lower than those set at the beginning of the year, to realize the 34th safety production year and as such, was ratified by CAAC North China Regional Administration to be the Company Passing 2019 Safety Assessment.

Beijing Kailan established a sound safety production management organization, consolidated the basic work of enterprise safety production management, strengthened on-site supervision and inspection of its affiliates, deepened the investigation of hidden dangers in key parts such as production workshops and warehouses, and selected third-party professional organizations for "inspection of fire control electrical equipment". Guided by problems, it implemented such rectification measures as monitoring the environment of the production sites, renovating power lines, and improving safety warning signs in workshops; organized activities like safety production training and safety knowledge questions and answers, and took a number of occupational health and health protection measures to effectively improve all employees' work safety awareness, promote the legalization, standardization, and systemization of safety production management, and achieve zero-accident production over the entire year.

The Asset Company attached great importance to daily safety precautions and adopted effective and proactive measures to prevent problems. It implemented grid management of fire protection and power supply and distribution in the office blocks of the Group, standardized the maintenance of fire safety facilities and equipment, conducted normal inspections of emergency lights and evacuation indicator systems, and established a daytime and night park inspection registration system; strengthened the vehicle and personnel registration management system in the park; highlighted the ideological construction of motor vehicle drivers to enhance their safety awareness and service awareness; strictly controlled the purchase, production and storage of food for the staff canteen to ensure food safety and provide a strong support for the overall safe operation of the park.





Provide Training on Safety Skills

In accordance with its annual safety training plan, CAS provided pertinent trainings on safety knowledge, safety skills, and job skills in many forms. The headquarters of the Company organized self-study questions on safety knowledge, safe driving experience in driving schools, and on-site fire self-rescue drills, and distributed safety education brochures, carried out various forms of training such as classroom lectures and out-of-office training, which effectively raised employees' safety awareness and safety knowledge.

The Company's affiliates carried out targeted trainings on fire protection, transportation, emergency care, occupational health protection based on their specific conditions, effectively improving the safety responsibilities and safety prevention capabilities of employees at all levels, and hence generally raising the safety production management and control capability of the company.

In 2019, CAS conducted a live fire emergency evacuation drill, which effectively improved employees' awareness of self-rescue, revised and improved fire emergency evacuation procedures, optimized escape routes, and provided necessary firefighting and emergency rescue supplies for the office premises to enhance the disaster prevention and self-rescue ability of the Company.

China General Aviation set up an emergency management department, and successively carried out 7 emergency drills including helicopter emergency rescue, S-92 helicopter ground fire, and aircraft overshooting the runway, to greatly increase its ability of emergency management and response. Kailan carried out comprehensive fire emergency drills, emergency escape and firefighting drills, to elevate employees' awareness of fire safety and exercised their fire handling capabilities. Beijing Aircraft Carpet Co., Ltd. conducted comprehensive emergency plans and firefighting emergency drills, to raise the team's comprehensive emergency response level.





Implement Safety Production Inspection

2019年,时值建国 70周年大庆,中国航材坚持隐患防 治并举,对所属各公司深入开展了安全生产大检查,持 续开展危险源辨识和隐患排查治理,加大专项检查工作 力度,提高突击检查次数。针对安全隐患,及时出手、 深挖内因,确保安全问题早发现,早解决。先后组织四 期安全大检查,涵盖八家二级单位、三家三级单位、十 多个部门、一个运行施工基地。集团公司全员参与,集 团领导带队检查指导,确保全年安全生产无事故,切实 担负起企业的安全责任。 In 2019, marking the 70th Anniversary of the Founding of the People's Republic of China, CAS insisted on the prevention and control of hidden dangers, carried out in-depth safety production inspections of its affiliated companies, continued to carry out hazard identification and hidden danger investigation and management, intensified special inspections, and raised frequency unannounced inspections. In response to potential safety hazards, it promptly took actions and dug deep into internal causes to ensure early detection and early resolution of safety problems. It organized four major safety inspections successively, covering eight secondary units, three third-level units, more than ten departments, and one operation and construction base. All of the Company leaders participated and personally led the inspections and provided guidance, to discover totally 49 problems, complete 43 rectification completion rate of 88%. It earnestly assumed the safety responsibilities through ensuring no accident over the year.

技术装备公司通过日常宣传教育和培养员工的节能意 识,自觉关闭不用的耗电设备,及时关闭水龙头,努力 减少各种能源消耗和资源浪费。工休时间认真检查,确 保空调和照明完全关闭。及时维修更换设施设备,杜绝 跑冒滴漏的现象,减少水资源浪费。在各类会议期间自 带水杯,不使用一次性水杯。


In 2019, CAS took the scientific development concept and green and sustainable development as its philosophy, established the awareness of energy conservation and emission reduction, actively promoted the social and economic significance of energy conservation and emission reduction, and created a good energy conservation and emission reduction atmosphere. The headquarters and each subsidiary of CAS started from their respective businesses and minor matters, fully implemented the environmental protection, energy saving and emission reduction work, highlighted details, saved office costs, actively practiced energy saving and emission reduction, and reduced resource waste, to effectively fulfill the corporate social responsibility for energy conservation and emission reduction.

CAS Co., Ltd. strengthened the purchase and management of office supplies and low-consumption supplies, promoted electronic document editing and processing, adopted eco-friendly paper for double-sided printing and copying to reduce paper waste; advocated lighting by natural light and walking instead of taking the elevator at the lower floors, and cultivated good habits from saving each drop of water and each KWH of electricity.

The Technology and Equipment Company made daily publicity and education to cultivate employees' awareness of energy conservation, so that they would consciously shut down power-consuming equipment not working and turn off the faucet in time to reduce energy consumption and resource waste, check carefully during work breaks to ensure that the air conditioning and lighting are turned off, maintain and replace facilities and equipment in a timely manner to prevent water and thus to reduce water waste. At all meetings, the company leaders took the lead in bringing their own cups instead of using disposable water cups.

Beijing Kailan stressed on environmental protection work and elevated employees' awareness of environmental protection through publicity and education on environmental protection; strengthened the management and supervision of environmental protection work of its affiliated production units, regularly conducted maintenance and repair of environmental protection facilities and equipment, and earnestly tested such items as waste water and waste gas, with all testing results meeting the standard and no environmental problem happening throughout the year.

The General Aviation Company strictly complied with the relevant requirements of CAAC on aviation fuel consumption in general aviation operation and strictly controlled the quality and quantity of fuel used in flight, for the purpose of environmental protection and energy conservation; minimized the use of company cars for business trips and reduced vehicle consumption, advocated low-carbon travel, promoted green consumption, promoted green life, and focused on power, water, and fuel saving, to lay the foundation for ensuring the fulfillment of the annual energy-saving and emission-reduction binding targets.



中国航材紧紧围绕"一优四强"发展战略,形成了涵盖 法律事务、合规管理、内控建设、风险管理职能的"大 法治"建设格局,加强风险事前预防、事中控制和事后 补救,采取多种措施保障公司改革发展。公司历史遗留 的法律纠纷案件全部解决,未因自身违法违规引发新的法 律纠纷案件,为公司创造了良好的经营环境。

CAS strictly abides by national laws and regulations, industry rules and business ethics, operates in good faith, and strictly performs economic contracts. We focus on establishing good cooperative relations with the government, shareholders, partners, creditors, suppliers and customers, and timely communicate with the stakeholders and the public to develop company information and strive to achieve common development.

Closely following the development strategy of "One Advantageous Platform and Four Strong Sub-platforms", CAS has formed a "big rule of law" construction pattern covering legal affairs, compliance management, internal control construction and risk management functions, to protect the company's reform and development with various measures such as prerisk prevention, in-risk control and post-risk remediation. The legal disputes left over from history were all resolved, and no new legal disputes were caused by violation of laws and regulations, which created a good business environment.

At the same time, we further improved the centralized law learning system for leading cadres, combined the work level of "key minority", strengthened the pertinence of law promotion, carried out the special law classroom in the Group Party Committee, to enable leaders to apply the thinking and method of rule of law to resolve contradictions, balance interests, and solve problems.

加强风险管理与内控 Strengthen Risk Management and Internal Control

中国航材深入贯彻落实党的十九大关于打好防范化解重大风险攻坚战的战略部署,以服务集团改革发展、防控重大风险为目标, 完善体制机制,创新方式方法,持续加强"三道防线"主体责任,不断夯实公司全面风险管理基础,及时组织研判和应对各类风险, 深入开展重大项目专项风险审查和评估,强化重大风险预警和过程管控,不断提升风险防控能力。

坚持规章制度建设与执行为主线,结合公司内部审计、全面风险管理、巡视巡查等工作,完善内控机制,将内部控制融入岗 位责任体系中,把每一个控制点落实到具体岗位,形成企业内部全员、全过程、全方位参与的良好局面,有效提升资源配置 效率和防范经营风险能力。2019年,中国航材集团风险管理效果明显,各类风险总体受控,未发生影响集团战略目标与长远 发展的重大风险事件。

CAS thoroughly implemented the strategic deployment of the Party's 19th National Congress on tackling and defusing the major risks, with the goal of serving the Group's reform and development and prevention and control of major risks, consummated systems and mechanisms, innovated methods, continued to strengthen the main responsibility of the "three lines of defense", to continuously consolidate its comprehensive risk management foundation; organized research, judgment and response to risks in a timely manner, conducted in-depth special risk review and assessment of major projects, and intensified major risk early warning and process management and control, to elevate risk prevention and control capabilities.

Based on the construction and implementation of rules and regulations, combined with the company's internal audit, comprehensive risk management and patrolling inspection inspections, CAS improved the internal control mechanism through integrating internal control into the post responsibility system. Each control point is assigned to the specific position, realizing participation by all members, in the whole process and from all aspects, to effectively improve resource allocation efficiency and prevent operational risks. In 2019, CAS achieved evident risk management effect, brought all risks under control and had no major risk event that affected the strategic goals and long-term development of the Holding Company.

中国航材紧紧围绕内部审计、审计管理、内控评价、违规经营投资责任追究以及企业年度工作报告等内容开展审计监督 工作,加强审计机构和审计队伍建设,五家重要二级子公司设置内部审计岗位,并配备兼职审计人员;开展集团公司年 度内部控制自我评价工作,揭示公司经营管理的薄弱环节和内部控制缺陷;开展企业年度工作报告编报工作,为国家部 委了解企业经营管理情况提供基础资料。通过盯紧重要企业、关键业务以及国家政策落实等事项,有效发挥内部审计监 督服务职能,为促进集团公司依法合规经营和高质量发展提供保障。

CAS conducted audit monitoring work from aspects of internal audit, audit management, internal control assessment, accountability for illegal operations and investment, and corporate annual work reports, strengthened the construction of audit institutions and audit teams, set up the internal audit position in five major secondary subsidiaries, and at the same time recruited part-time auditors; carried out the annual internal control self-assessment work of the Holding Company to reveal the weak sections in operation and management and the internal control deficiencies; compiled the company's annual work report, to provide the state ministries and commissions with its basic information on business operation and management. It finished 10 audits including economic responsibility audit and financial revenue and expenditure audits, found 28 problems, put forward 30 audit suggestions, made timely rectification of problems, consummated 5 related systems, recovered 670,000 RMB improper subsidies and cleared 4.45 million RMB accounts receivable. Through paying close attention to important enterprises, key businesses, and the implementation of national policies and other matters, CAS gave full play to the monitoring and service function of internal audit, to provide support for the promotion of legal and compliance operations and high-quality development of the Holding Company.

Apple planting is the leading industry in Baishui County and the main source of income for the local people. In 2019, CAS invested to buy 200mu (133,333m²) to build two Baishui Apple Poverty Alleviation Industry Demonstration Parks, to make demonstrations in terms of the promotion of new varieties, green organic dwarf stock planting, and the application of scientific management and protection technologies. It adopted the model of "entrusted management, storage, and sales" as well as the provision of labor and year-end dividends, to reduce business risks, solve the problem of insufficient labor for poor households, effectively increase the yield and quality of apples, and promote the modernization of apple planting in designated counties, so that the apple industry could become a pillar industry for the people of Baishui to shake off poverty and become prosperous.

To help Baishui County optimize the agricultural industry structure and develop a stable blood-making ability, CAS invested RMB 2.15 million in aviation breeding poverty alleviation projects from 2018 to 2019, helped build standardized seedling greenhouses, installed standard seedbeds and automatic spray facilities; established planting demonstration sites and expanded the planting area; provided training on scientific planting management techniques; guided the establishment of own brand, expanded sales channels, and increased the market price by more than 30% compared with local varieties. As a result, the growers were enthusiastic and actively purchased the aviation seedlings. Some impoverished villages also successfully planted aviation cherry tomatoes in the open air, to play a key role in driving poverty alleviation and achieving prosperity.

\$ 森林火灾抢险救援

Forest Fire Rescue

2019年4月8日,景德镇市珠山区竟成镇银坑村发生森林火灾,4月9日火情蔓延至枫树山林场范围,过火面积约20公顷。由于着火地区地势复杂,山高、坡陡、路窄,大型灭火车辆和装备无法进入,江西省森林防火指挥部和江西省航空护林局,紧急调用中国航材所属中国通用航空有限公司正在南昌执行航空护林任务的AC313直升机火速驰援景德镇,同时正在景德镇进行科研试飞的AC313也奉命加入洒水灭火任务。2架AC313直升机驾驶员凭借丰富经验和飞行控制能力,将水精准地洒在火线上,下午13:35分,大火全部扑灭。整个抢险救援过程共计飞行4小时6分,吊桶洒水17次50余吨,为控制火情蔓延、加速灭火进程提供了重要保障。

On April 8, 2019, a forest fire broke out in Yinkeng Village, Jingcheng Town, Zhushan District, Jingdezhen City. On April 9, the fire spread to the Fengshushan Forest Farm, covering about 20 hectares. Due to the complex terrain, high mountains, steep slopes, and narrow roads, making it impossible for large fire-fighting vehicles and equipment to get close, Jiangxi Provincial Forest Fire Prevention Command and the Jiangxi Provincial Aviation Forest Protection Bureau urgently called China General Aviation Co., Ltd. to ask for AC313 helicopter performing the forest protection mission in Nanchang to rush to aid Jingdezhen. At the same time, the AC313, which was conducting scientific research and test flights in Jingdezhen, was also ordered to join the firefighting mission. The two AC313 helicopter pilots utilized their rich experience and flight control capabilities to accurately spill water on the fires, to put out the fire at 13:35. The entire rescue process took 4 hours and 6 minutes, sprinkled water 17 times, consuming more than 50t water, which provided an important guarantee for controlling and extinguishing the fire.

Emergency flight to rescue the wounded

2019年1月22日凌晨,中国通航公司蓬莱基地接到紧急电话,中海油平台有2名工作人员突然受伤,情况十分危急, 需要立即撤离采油平台送至医院救治。蓬莱基地接到通知后,第一时间组织机组进行航前准备并下达急救飞行指令,基 地相关工作人员迅速集合,准备急救。由于公司从未飞过此平台,飞行机长积极联系获取相关飞行资料,按照执行急救 任务的相关文件,中国通航应急救援飞机迅速起飞,顺利抵达石油平台并搭载受伤人员及时返回基地送上救护车。由于 抢救及时,两名受伤人员均脱离生命危险。此次紧急飞行任务的圆满执行,体现了通航机组的职业素质,充分展现了机 组面对突发事件的快速反应能力和水平。

In the early morning of January 22, 2019, China General Aviation Penglai Base received an emergency call, saying that two workers of the CNOOC platform were suddenly injured, in a very critical situation, and needed to be evacuated from the oil production platform and sent to the hospital. After receiving the notification, the Penglai Base immediately organized the crew to make pre-flight preparations and issue first aid flight instructions. The relevant staff of the Base quickly assembled to prepare for first aid. Since this was a new platform for the Base, the flight captain actively contacted relevant parties to obtain flight information. According to the relevant documents for the implementation of emergency missions, the China General Aviation S-76 aircraft quickly took off, arrived at the oil platform and carried the injured back to the Base in time for ambulance. Thanks to the timely rescue, the two injured were out of danger. The successful execution of this emergency flight mission has reflected the professional quality of the general aviation crew and fully showcased the crew's ability and level of rapid response to emergencies.
